City Council Meeting Minutes West Peoria City Hall ORIA Tuesday, February 11, 2025 at 7:00 p.m.

- 1. Mayor Dillon called the meeting to Order at 7:00 p.m. and led the Pledge of Allegiance.
- 2. Roll Call: Members present were Mayor Dillon, Alderpersons Corbett, Dohm, Dillon, Mathewson, Abraham, Ruskusky, Menke, and Silver. Also present were City Administrator Krider, City Treasurer McGill, residents Bonnie Farrell and Emily Waite, Deputy McGinnis, and Clerk Barnes. City Attorney Connor and residents Priscilla Peterson and Susan Schlupp attended remotely.
- 3. There were no Additions to/or Deletions from the Agenda.
- 4. A Motion to Approve Minutes from the regular meeting of January 28, 2025 was made by Alderperson Dohm and seconded by Alderperson Menke. There was no discussion. Roll call votes: Ayes: Alderpersons: Dohm, Menke, Corbett, Dillon, Mathewson, Abraham, Ruskusky, and Silver – 8 Nays: - 0 Abstentions: - 0 Absent: - 0 Motion carried.
- Community Police Report was given by Deputy McGinnis. In February so far there have been 81 traffic stops, with 23 Citations, and 18 arrests in West Peoria. There were 4 domestic batteries, 4 DUIs, 4 suspended/revoked driver's licenses, 3 warrant arrests, 2 meth possessions, 2 residential burglaries, 2 criminal damage to property, 2 aggravated fleeing and eluding, 2 other fleeing and eluding, 2 obstructions of justice, and one each of the following: controlled substance possession, forgery, criminal trespass, aggravated assault with a firearm, unlawful use of a weapon, aggravated battery of police, failure to remain at the scene of an accident, and a theft over \$500.00.
- 6. Mayor's Report: West Peoria Liquors now has a State License and is open for business. Curly Shawarma is now open for business. The Mayor gave a tour for the Volunteer Fire Department on Sunday to see the new City Hall in its current construction phase. St. Patrick's Parade sponsored by CORES will be March 8, 2025 starting at 11:00 a.m. on Farmington Road. September 1, 2025 we will have a Labor Day Parade on Farmington Road. There was a group meeting for prospective contractors at the house on MLK this morning, but no contractors showed up. The Neighborhood Watch meeting for tomorrow has been canceled because of weather. There is a Snow Ban in effect from tomorrow morning at 6:00 a.m. until Thursday, with 6-8 inches of snow predicted. Work continues on the new City Hall. The offices are painted and the lights are up. It is hoped that the Geothermal heating can be turned on tomorrow. The finish date is still expected at the end of March or beginning of April, with outside finishes to be completed such as sidewalks and the War Memorial. If anyone has a name that should be on that War Memorial, please call City Hall.
